Dave Mosher has been getting complaints. I am admin for over 200 safelists owned by Dave. Because Dave and I have both a personal and business relationship, he approached me as a courtesy before doing anything drastic. Up until now, I've had Dave hold off on pulling the trigger to block his sites.

Other safelist, TE, and mailer owners had already blocked his sites, but an unintended consequence, whether intentional or not on his part, when Matthew changed out his servers, the "banned lists" were not updated with new IP addresses so many of these attempts were rendered ineffective.

We have all invested (I know I have thousands into it with Lifetime Premium, Founder, Site Partner, etc.), we are putting forth the effort that generates revenue FOR HIM, but we are not being paid commissions for our efforts.

I'm not a lawyer, but I believe, in USA, for anything over \$1000 it could be considered GRAND THEFT, but prosecuting him would be impossible because he keeps hiding behind his Canadian citizenship.

I personally am not investing one more dime with him until I am paid.

I'm not into social media but it may be worthwhile having some forum where we can determine the scope and severity of this problem and maybe figure out an approach to collectively confront him.

Earning commissions means nothing if you cannot get paid.
